AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF DUNCOMBE, IOWA, BY AMENDING PORTIONS OF TITLE VI, "BILLING CHARGES".

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DUNCOME, IOWA:

Section 2. That the Code of Ordinances of the City of Duncombe, Iowa, be amended by repealing 6-5-8 "WATER RATES" and the following adopted in lieu thereof:

6-5-8 WATER RATES. Water shall be furnished at the following monthly rates per property serviced within the City limits:

The first 2,000 gallons-\$28.62 All over 2,000 gallons-\$6.48 per 1,000 gallons

Bulk sales-\$12.42 for every 1,000 gallons

The minimum charge shall be \$28.62 per household or business building per billing month.

Section 2. That the Code of Ordinances of the City of Duncombe, Iowa, be amended by repealing 6-5-12 "RATE of SEWER RENT AND MANNER OF PAYMENT" and the following adopted in lieu thereof:

6-5-12 SEWER RATE. The rate of sewer rent shall be:

The first 2,000 gallons-\$25.60 All over 2,000 gallons-\$3.40 per 1,000 gallon

The minimum charge shall be \$25.60 per household or business building per billing month.

Section 3. That the Code of Ordinances of the City of Duncombe, Iowa, be amended by repealing 6-5-9 "REFUSE COLLECTION RATES" and the following adopted in lieu thereof:

- 6-5-9 REFUSE COLLECTION RATES. There shall be collected by the City for its services in collecting garbage and rubbish, the following mandatory fees.
 - 1. Rate. For each customer with alley or curb pickup, \$9.50 per month for one garbage or rubbish collection each week, \$50.00 per month for a dumpster. In the event that alley or curb pickup for any residence is not feasible, the City Clerk is hereby empowered to enter into an agreement with such resident for any additional charge to be paid by such resident for any other location of pickup that may be agreed upon.

2. Customers shall utilize containers designed and described in Chapter 5 Section 6-4-1: Definitions No. 4: "Can". All cans shall have a maximum capacity of 32 gallons. The City will collect up to two cans per residential unit, or up to six bags that will fit into the two cans, at the normal rate charged for collection, There will be an additional charge for additional containers determined by the carrier and City and passed onto the property owner. This monthly fee per premise will be increased when the solid waste collector increases fees charged to the City.

Section 4. That the Code of Ordinances of the City of Duncombe, Iowa, be amended by repealing 6-5-11 "RECYCLING RATES" and the following adopted in lieu thereof:

6-5-11 RECYCLING RATES: There shall be collected by the City for recycling services a fee of \$2.00 per residence.

Section 2. Repealer. All ordinances, ordinance amendments or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. Severability Clause. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. This ordinance shall take effect upon publication.
